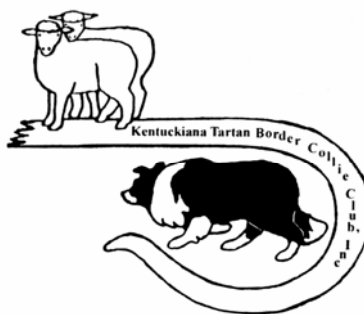


# *Tartan Tails*
